NOTE: Consumers requiring service for a period less than 30 days shall pay the monthly minimum charge plus the cost of the water usage.

TERMS OF PAYMENT: Bills are due when rendered. There is a 10% penalty after the due date of bill. A due date is noted on the original bill. If payment is not received by the due date then a 10% penalty is attached and the customer is sent a delinquent notice establishing a final date to pay the entire bill including the penalty. If the customer fails to make payment by the date noted on the delinquent notice then the service will be terminated without further notice. If the Authority personnel appear at the customer service location to collect a delinquent or NSF bill, then a \$50.00 collection charge is added to the bill. If the delinquent or NSF account has been shut off an additional \$50.00 charge will be collected to turn the water supply back on the following business day after the bill and collection charges have been paid in full at the business office between the hours of 8:30 AM and 3:00 PM. If you're having a problem in paying the water bill, it is the customer's responsibility to contact the office before the due date on the original bill.

<u>SCHEDULE OF RATES</u>: This schedule applies to any water service throughout the entire territory served, other than water service to which another rate schedule is specifically applicable.
